ACS,

My name is Dennis Jay Geier. I am an American Citizen. I have been living in Guiyang, Guizhou China for five years with my Chinese Nation wife Yimei Zhang, and our son Haoyu Zhang. Due to medical reasons, mostly cardiac related, I had to return to the USA for cardia intervention on November 6, 2021. My son Haoyu Zhang, which is five years old, and only speaks English, came with me to the USA as we waited for the adjudication of my wife, Yimei Zhang's I-290B for medical Humanitarian Parole.

I am reaching out to you for help to communicate with HAB in Washington DC. I believe the Embassy has more ways to communicate than the average American Citizen. It has been fruitless for me, and the Congressional case worker in my Ohio Senators office in Columbus, Ohio to get answers. This is an urgent matter.

My wife is still in Guiyang, Guizhou China. I need her here in the USA to help me take care of our five year old son Haoyu as I continue medical intervention. There is NO ONE here to help me take care of our son. It is only me. Procedures have been postponed that would require a hospital stay because there is no one here to care for our son except me. My doctors have written letters (attached) that make it clear that I need cardiac intervention and it is critical that my wife (a parent) to be here to care for our son but for my care as well. God forbid that if anything happened to me our son would be here alone.

The attached letters were sent to my Congressional case worker that were forwarded to the Congressional liaison at HAB in Washington DC who in turn assured that these letters of new medical evidence were received, or put in the fille of the HAB Chief adjudicating my wife's case. Please note that it had already been well over 90 days being adjudicated before this new evidence was submitted. My feeling is that the adjudicating officer never received it or looked at the new evidence. This was an emergency. It was a true Humanitarian need.

<u>History</u>: I filed immigration visa for both my wife and son. My wife was denied. My son was approved an IR2 visa. I filed I-601 Waiver for my wife. It was denied. I filed the I-131 for Humanitarian Parole. It was denied because there was not a preponderance of evidence to support a Humanitarian need. I filed the I-290B to reopen/reconsider, and later in the adjudication process, once back in the USA with our son, is when the new supporting medical evidence was obtained by my doctors and then forwarded to HAB. I have attached the new evidence from doctors with an urgent request that my wife Yimei Zhang be permitted to be with me, and to take care of our son.
